ORDINANCE NO. 2019-1

AN ORDINANCE CODIFYING ALL PRIOR ORDINANCES OF THE COMMISSION AND ESTABLISHING AN ADMINISTRATIVE CODE BASED ON THOSE PREVIOUSLY APPROVED ORDINANCES

WHEREAS, since its inception, the Commission has adopted various ordinances related to its operation and the maintenance of public health in accordance with the laws, regulations and rules concerning the administration of public health in the State of New Jersey; and

WHEREAS, in an effort to become more efficient, the Commission determined to arrange its previously-adopted ordinances into an organized administrative code; and

WHEREAS, the Commission finds that this is in its best interest for the administration of public health to its member and contract municipalities.

NOW, THEREFORE, BE IT ORDAINED by the Monmouth County Regional Health Commission No. 1, created and operating pursuant to N.J.S.A. 26:3-83 et seq., as follows:

Section 1. There is hereby established an "Administrative Code of the Monmouth County Regional Health Commission No. 1," which shall be comprised of the following chapters, in substantially the same form as attached hereto and incorporated herein by reference:

Section 2. REPEALER. All prior Ordinances or parts of same consistent and/or inconsistent with any of this Ordinance established hereunder are hereby repealed.

- SEVERABILITY. In the event that a court of competent jurisdiction shall declare any section, sentence or clause of this Ordinance unconstitutional, such declaration shall not in any manner prejudice the enforcement of the remaining provisions.
- <u>Section 4.</u> EFFECTIVE. This Ordinance shall take effect twenty (30) days after the first publication thereof after final adoption as provided by law.
