Resolution of the Monmouth County Regional Health Commission No. 1 Authorizing the Sale of Property No Longer Needed for Public Use on an Online Auction Website

WHEREAS, the Monmouth County Regional Health Commission No.1 (herein "MCRHC") has determined that the following vehicles are no longer needed for public use:

- 2008 Ford Fusion Mileage 70,000 Kelly Blue Book Private Party Cost = \$4,583 - \$5,559
- 2009 Chevy Cobalt Mileage 69,000 Kelly Blue Book Private Party Cost = \$3,350 - \$4,807

WHEREAS, the MCRHC has established and adopted a "*Procedure for Public Sale of Capital Property*;" and

WHEREAS, the "*Procedure for Public Sale of Capital Property*" states in Step #4 "If no member or contract town has interest in purchasing said property, it shall be placed in a public auction"; and

WHEREAS, the MCRHC intends to utilize the online auction services of Municibid located at <https://municibid.com>; and

WHEREAS, the sale of the surplus vehicles shall be conducted through Municibid pursuant to New Jersey State Contract T2581 – Auctioneering Services: Internet Auctions to Sell Surplus Property - Bid #19DPP00272; and

WHEREAS, the sales are being conducted pursuant to N.J.S.A. 40A:11-36 and the guidance set forth in the Division of Local Government Services' Local Finance Notice 2019-15; and

WHEREAS, the "*Procedure for Public Sale of Capital Property*" states in Step #5 "where Capital Property is a vehicle, the Health Officer as the option to trade vehicle in to dealership offsetting cost of new / leased vehicle."

NOW THEREFORE, BE IT RESOLVED that the MCRHC in accordance with its "*Procedure for Public Sale of Capital Property*" is hereby authorized to sell the surplus vehicles on an online auction website entitled <https://municibid.com> and indicates its intention and willingness to participate in said area-wide government public auction or to trade in to dealership at time of new vehicle purchase / lease the following vehicles:

- 2008 Ford Fusion Mileage 70,000
- 2009 Chevy Cobalt Mileage 69,000

BE IT FURTHER RESOLVED that the MCRHC authorizes its Health Officer to sign on behalf of the MCRHC all Auction Documents provided to this agency by www.municibid.com related to the auctioning of these two vehicles.

BE IT FURTHER RESOLVED that a copy of this resolution shall be on file in the Monmouth County Regional Health Commission No.1 and available for inspection as required by law.
